The safety glasses B502/B503/B504/B505-1/B507S/B508/B509/B510 and B545 protect against UV-radiation on the level 2C-1.2; the safety glasses B517 and B532 protect against UV-and sunglare radiation on the protection level 2C-3/5-3.1. The symbols are scale numbers for: 2C: UV-filters, colour recognition is not impaired; 5: sunglare filters. The picture of each model is attached as annex-1.
- (4) The safety glasses mentioned under 4 meet the basic safety and health requirements of ANNEX 2 of the PPE Regulation (EU) 2016/425 and Directive 2001/95/EC on General Product safety.
